- **1.** Call to Order: Chairman Garcia called the meeting to order at 7:30 p.m.

- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions / Emergency Additions:** A resolution of the City of Hialeah Gardens, Florida, certifying the results of the scheduled general election on March 3, 2015; providing for effectice date.
- **6. Review of Minutes: February 03, 2015.** Chairman Garcia made a motion to approve the minutes of February 03, 2015 seconded by Councilman Merida. The motion was unanimously approved.

7A. Proposed Resolution:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, CERTIFYING THE RESULTS OF THE SCHEDULED GENERAL ELECTION ON MARCH 3, 2015; PROVIDING FOR EFFECTIVE DATE.

Ms. Martinez-Ruiz read the full title of the resolution into the record. Chairman Garcia then made a motion to approve, seconded by Councilman Piña. The motion was unanimously approved.

 Request for approval of 2COP license for Adrian Fish Market & Restaurant, 13115 W. Okeechobee Road, Suites 11-116, Hialeah Gardens, Florida. Owner: Mr. Adolfo Benitez-Garcia.

Chairman Garcia read item eight into the record. The applicant Adolfo Benitez-Garcia was present and came forward. Mayor De La Cruz appointed Mr. Ralph Cabrera for the Personnel Review Board, and Councilman Merida appointed Mr. Armando Abreu for the Personnel Review Board as well.
