MINUTES

CITY OF HIALEAH GARDENS TUESDAY, MAY 1, 2007

- 1. Call to Order: Chairman Luciano Garcia called the meeting to order at 7:40 p.m.
- 2. **Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, and Councilman Jorge A. Merida. Also present were Mayor Yioset De La Cruz and City Attorney Charles A. Citrin. Councilman Rolando Piña was absent
- 3. **Invocation:** Chairman Garcia led the invocation
- 4. **Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. **Deletions/Emergency Additions:** None were offered.
- 6. **Review of Minutes:** April 17, 2007. Chairman Garcia made a motion to approve the minutes of April 17, 2007, seconded by Councilman Merida. The motion was unanimously approved.
- 7 **Public Comments:** None were offered
- 8. Recommendation for Police Station Fencing RFP No. PW-07-B110: Mr. Jose M. Lopez, Public Works Director.

Mr. Jose M. Lopez, Public Works Director came forward and gave recommendations to award the contract to Island Fence of Florida, Inc. who was the only responsive bidder to the request for proposals number PW-07-B110. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. Mr. Marcos Piloto, O.M.B. Director came forward and gave details of the amendments to the interlocal agreement with Miami-Dade County for the city's surtax proceeds. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS. FLORIDA. AUTHORIZING THE AWARD OF A **CONTRACT FOR CITY FIREWORKS** THE ENTERTAINMENT TO ADD FIRE, INC., FOR THE *INDEPENDENCE* DAY**CELEBRATION:** CITY'S UTILIZING AN EXISTING MUNICIPAL CONTRACT FROM THE CITY OF NORTH BAY VILLAGE AS ALLOWED BY ORDINANCE 2002-54; AUTHORIZING THE APPROPRIATE OFFICIALS TO EXECUTE AN AGREEMENT WITH ADD FIRE, INC.; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Walter Dubon, Director of Parks and Recreation came forward and gave information regarding the contract with Add Fire, Inc. who will provide the fireworks display for the 4th of July celebration for a total cost of \$68,000.00. Chairman Garcia made a motion to approve, seconded by Councilman Merida and the motion was unanimously approved.

Councilman Gutierrez stated that he would be abstaining from voting on this item due to professional conflict of interest. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was approved by individualized voice vote (3-0 with Councilman Gutierrez abstaining from voting on this item).

Mr. Alvarez stated that his attorney was not present and wanted the item tabled. Chairman Garcia made a motion to table the item until the end of the meeting to give the attorney the opportunity to arrive, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (**Tabled 4-0**).

The meeting reconvened at 8:24 p.m. Chairman Garcia made a motion to remove the item from table, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (4-0). Mr. Citrin swore in all those who would be testifying on the item. Mr. Javier Vazquez as legal counsel for the applicant was present. Mrs. Mirtha S. Gonzalez, Chief Zoning Official came forward and gave staff recommendations. Mr. Vazquez gave details regarding the application for a land use change from estate residential to low density and why it should be approved. Mr. Vazquez argued that the parcel in question has different zoning designations on the four sides of the property including low density residential and estate density and therefore any future development should take this fact into consideration when rendering a decision. Mr. Juan Carlos Alvarez, the applicant came forward and offered his comments on the proposed project. A lengthy commentary ensued from Mr. Alvarez in which he offered several different site plans that could be tied to a covenant with the city. Mr. Vazquez came forward again and reiterated his request for the Council's consideration of the zoning designation of the surrounding properties of the parcel in question. Chairman Garcia opened the public hearing at 8:59 p.m.
